



### **Romney Can't Walk Back His Support for Romney-Ryan Budget**

Today, before Mitt Romney even took the stage to introduce his new running mate, his adviser Bay Buchanan told [NBC News](#) that Romney's budget plans are "not an embrace, line by line, of the Ryan plan. Mitt Romney has his own plan." And Romney campaign internal talking points posted by [CNN](#) this morning showed he plans to make this walk-back official.

That's strange, since Romney has strongly endorsed the Romney-Ryan Budget throughout his campaign – turning time and time again to the same tax cuts for the wealthiest Americans on the backs of middle-class families as Paul Ryan has championed in Congress. The Romney-Ryan Budget would turn Medicare into a voucher program, make severe cuts to programs like education that would hamper job creation, and repeal health care reform and key protections in Wall Street reform – all to pay for massive tax cuts for millionaires and billionaires.

Paul Ryan is the perfect pick to implement Mitt Romney's agenda, since they are one and the same: more budget-busting tax cuts for the wealthy no matter the expense for the middle class or the consequences for our economy.
