

INSTRUCTIONS FOR COMPLETING THE UNDERAGE FORM AND CASINO RULES REGARDING UNDERAGE INDIVIDUALS:

Children may attend the conference; however, Pennsylvania Gaming Control Board regulations apply. In Pennsylvania, individuals must be at least **21 years of age** to enter any area where slot machines or table games are operated, to gamble, or to receive any complimentary services from the casino. Please see Key Laws and Restrictions below.

Rivers Casino requires an Underage Form to be completed for ALL attendees under age 21. This form can be completed by the Local for ALL children from that Local OR by individual delegates. Be sure to list the chaperone for each child as the person who will escort the child/children to any of the events as they are required to be with the child/children as they enter and leave.

Please indicate your name and local # at the top of the Underage Form. Do **not** print, sign or date the form at the bottom of the page. Forms must be received **no later than Wednesday, May 20, 2026**, to allow sufficient time for approval.

*****IMPORTANT NOTICE:**

Underage guests without prior casino approval will not be permitted to attend any conference events. On-site approval is not available.

Pennsylvania Key Laws and Restrictions

- **Minimum Age:** *It is strictly unlawful for anyone under 21 to enter or remain on the gaming floor of a licensed casino facility.*
- **Gambling Prohibited:** *No one under the age of 21 may wager, play, or attempt to play any slot machine or table game. Winnings by an underage individual are remitted to the Pennsylvania Gaming Control Board (PGCB) to support compulsive and problem gambling programs.*
- **Unattended Minors:** *Adults are prohibited from leaving minors unattended anywhere on casino premises, including parking lots, garages, hotel rooms, and other venues.*
- **Penalties for Violations:**
 - **For Minors:** *Individuals under 21 who violate the law may be removed, face arrest, and potentially criminal prosecution.*
 - **For Adults:** *Adults who leave children unattended can face criminal prosecution for endangering the welfare of a child and are subject to placement on the PGCB's Involuntary Exclusion List, resulting in a statewide, potentially lifetime, ban from all Pennsylvania casinos.*
